

Exhibitor Weapon Sales Compliance Rules

Introduction

- Montreal Comiccon is committed to providing a safe and welcoming environment for all persons attending the convention.
- The Exhibitor Code of Conduct (included in the Montreal Comiccon Exhibitor Guide) states
 that exhibitors must "follow the guidelines, rules, regulations and policies of Montreal
 Comiccon".
- Montreal Comiccon prohibits the display (including under the counter storage) and sale of weapons that are not legally allowed to be sold in Canada (for additional information, please refer to the Montreal Comiccon Weapons Policy).

Montreal Comiccon Responsibilities

- Provide information to exhibitors on the weapons policy, the vendor weapon sales compliance rules and their obligations.
- Promote compliance with the policy through exhibitor education and support and compliance checks (review of weapons on display and for sale at exhibitor booths).
- Enforce the policy in a timely, fair, consistent and transparent manner.

Exhibitor Responsibilities

- As a condition of their involvement with Montreal Comiccon, exhibitors agree not to display or sell any illegal weapons at the convention. It is the exhibitor's responsibility to be familiar with the regulations prescribing illegal weapons. - Exhibitors will fully cooperate with Montreal Comiccon review, inspection and examination of any goods on display or for sale at the convention.

- Exhibitors will fully comply with all Montreal Comiccon directions regarding the enforcement of the weapons policy and vendor weapon sales compliance procedures.
- Exhibitors will immediately remove from the convention all weapons deemed by Montreal Comiccon to be illegal.

Montreal Comiccon Procedures for Enforcing Compliance

- Montreal Comiccon staff will conduct ongoing compliance checks with exhibitors.
- If Montreal Comiccon staff become aware that an exhibitor is selling illegal weapons, not respecting the Weapons Policy or not following these procedures, they will:
 - Complete an Incident Report (IR), immediately file the IR and provide a briefing to the Exhibition Hall Director, or their designate;
 - Ensure that the IR includes the employees' names, the exhibitor name and booth number, along with a description of the illegal weapon and/or policy breach;
 - Take no enforcement action against the exhibitor unless directed to do so by the Exhibition Hall Director or their designate.
- The Exhibitor Hall Director (or their designate) will, in a timely manner:
 - o Review and sign the IR; o Discuss the issue with the exhibitor;
 - Verify that there is a policy breach and/or an illegal weapon on display or for sale.
 This may involve a re-examination of the weapon by the Exhibitor Hall Director (or their designate) or others, at the discretion of Montreal Comiccon; and,
 - Warn the exhibitor that they are in violation of Montreal Comiccon policy and direct them to comply with the policy and/or immediately remove any and all illegal weapons from the convention for the duration of the show.
- Exhibitors who do not comply with enforcement or compliance direction from the Exhibition Hall Director, or their designate (e.g. they refuse to remove any and all illegal weapons) or who are found to be violating the policy after receiving a warning, will face further sanctions from Montreal Comiccon, which may include:
 - o Immediate removal from Montreal Comiccon; and/or
 - A ban from Montreal Comiccon and other conventions affiliated with Montreal Comiccon: and/or
 - o Other actions deemed appropriate by Montreal Comiccon.
